

## PUBLIC PATH DIVERSION ORDER

# HIGHWAYS ACT 1980

# **RIBBLE VALLEY BOROUGH COUNCIL**

## DIVERSION OF PUBLIC FOOTPATH No. 51 RIBCHESTER

This order is made by Ribble Valley Borough Council (the Authority) under Section 119 of the Highways Act 1980 (the 1980 Act) because it appears to the Authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the way should be diverted.

The applicant has agreed to defray any expenses, which are incurred in bringing the new site of the footpath into a fit condition for use by the public. All gates will be provided or modified so that they are 1.2 metres wide two way self closing gates to BS 5907:2006.

#### BY THIS ORDER:

- 1. The public right of way over the land situated at Ashmoor House, Ribchester shown by bold continuous lines on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up as from the date the Authority certifies that all work to bring the footpath, as described in Part 2 of the Schedule, into a fit condition for use by the public has been carried out.
- 2. There shall at the end of 14 days from the date of confirmation of this order be a public footpath over the land situated at Ashmoor House, Ribchester described in Part 2 of the Schedule and shown by bold broken lines on the map attached to this order.
- 3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

# PART 1 DESCRIPTION OF SITE OF EXISTING PATH OR WAY

#### Footpath No. 51.

From Ordnance Survey Grid Reference 6457 3609, Point B on the Order Plan in a generally north westerly direction for approximately 134 metres, to Ordnance Survey Grid Reference 6448 3619, Point C on the Order Plan, then in a generally north westerly direction for approximately 24 metres, to Ordnance Survey Grid Reference 6446 3621, Point D on the Order Plan, then in a generally northerly direction for approximately 31 metres to Ordnance Survey Grid Reference 6445 3624 Point E on the Order Plan, a total length of 189 metres. The existing path is shown by a bold line on the Order Plan and marked B - C - D - E.

#### PART 2

# DESCRIPTION OF SITE OF NEW PATH OR WAY

#### Footpath No. 51.

The new length of path to be created, being 2 metres wide, from Ordnance Survey Grid Reference 6457 3609 Point B on the Order Plan in a generally north westerly direction for approximately 15 metres to Ordnance Survey Grid Reference 6456 3610 Point F on the Order Plan, then in a generally north north easterly direction for approximately 19 metres to Ordnance Survey Grid Reference 6457 3612 Point G on the Order Plan, then in a generally north westerly direction for approximately 83 metres to Ordnance Survey Grid Reference 6453 3619 Point H on the Order Plan, then in a generally north easterly direction for approximately 85 metres to Ordnance Survey Grid Reference 6453 3619 Point H on the Order Plan, then in a generally north easterly direction for approximately 85 metres to Ordnance Survey Grid Reference 6445 3624 Point E on the order plan, a total length of 202 metres. The new path is shown by a bold broken line on the Order Plan and marked B - F - I - G - H - J - E.

The right of the owner of the soil to erect and maintain a 1.2 metres wide two way self closing gate to BS 5907:2006 at Ordnance Survey Grid Reference SD 6457 3612 point G on the Order Plan.

The right of the owner of the soil to provide and maintain a ditch crossing at Ordnance Survey Grid Reference SD 6447 3623 point J on the Order Plan.
