SITE: LAND TO THE SOUTH OF BENTLEA ROAD, GISBURN, CLITHEROE,  
LANCASHIRE, BB7 4EX

PROPOSAL: ERECTION OF 2 DETACHED DWELLINGS

1 ASSESSMENT

- 1.1 The application site lies to the south of Bentlea Road on the fringe of Gisburn. The land is presently in an agricultural use and is essentially an open field. The lands fronts onto Bentlea Road where it is proposed to take access for the development.
- 1.2 The application site lies outside of the defined settlement boundary as identified in the Ribble Valley Districtwide local plan within an area designated as open countryside.
- 1.3 The site itself rises in a southerly direction on entering the site from Bentlea Road.
- 1.4 Development plan policies are informed by government advice detailed in Planning Policy Guidance (PPG's) and Planning Policy Statements (PPS's). Following the recent withdrawal of the regional spacial strategy (RSS) then the proposal would have to be measured against those policies that have been saved from the Ribble Valley Local Plan (aRVDWLP).

1.6 Notwithstanding the above the Council have recently undertaken a review of potential housing sites to meet on going needs and this particular site has been specifically identified as part of that process.

1.7 The site has no relevant previous planning history.

## 2 INVOLVEMENT

2.1 The proposals compliance with adopted policy has not necessitated pre application negotiations with the local Authority however an informal discussion has been held with Colin Sharpe a senior planning officer who has suggested that in principle it would be appropriate to submit a formal planning application.

## 3 EVALUATION

3.1 The reasons for preparing this planning application on behalf of my clients are partly due to the identification of the site within the search process undertaken by the local authority and their own personal desire to construct a new family home for their own occupation. They presently live at Kirk Croft the adjacent property to the application site abutting the western boundary.

## 4 DESIGN

4.1 The design of the right hand unit when viewed from Bentlea Road has been influenced by the clients desire to fulfil their own particular family needs with 3 growing children. Both properties are to be constructed from natural stone with blue slate roofs albeit that one of the properties will have a certain amount of living accommodation within the roof space.

- 4.2 The design philosophy is to produce buildings of a traditional vernacular style which will fit more harmoniously within the local street scene notwithstanding the fact that various properties in the immediate locality range from more modern 1970's design to more traditional older properties

## 5 ACCESS

- 5.1 It is proposed to create 2 new combined pedestrian and vehicular accesses to serve the 2 properties from Bentlea Road and whilst there will be a change in level from Bentlea Road to the dwellings level access can be provided into the dwellings.
