### Exemption from fees

The following premises are exempt from paying a fee in the circumstances outlined below:

- No fee is payable by a church hall, chapel hall or a premises of a similar nature in respect of a premises licence which only authorises the provision of entertainment. If such premises wish to apply for a premises licence authorising the sale of alcohol they must pay a fee calculated in accordance with the provisions set out above. The same applies to village halls, parish and community halls or other premises of a similar nature.
- No fee is payable by a school providing education for pupils up to Year 13 or a sixth form college for a premises licence which only authorises the provision of entertainment carried on by the school or sixth form college itself at the school or college premises for the purposes of the school or college. If the school wishes to obtain a premises licence, which authorises other organisations to use the premises for providing entertainment, they must pay a fee calculated in accordance with the provisions set out above.
