1 PURPOSE

1.1 To consider the allocation of voluntary sector grants as proposed by a sub-group of this committee, in accordance with the scheme approved in November 2006.

2 BACKGROUND

- 2.1 The Council has a number of grant schemes in operation including specific ones such as recreation grants, culture grants and sports grants to more general ones administered mainly by Policy and Finance Committee.
- 2.2 In November 2006 this committee approved a review of the way the Council administers general grants.
- 2.3 In accordance with the review a voluntary grant sub-group of this Committee was established to consider the application received and recommend the allocation of funds.
- 2.4 In November 2009, all applicants from 2009 and any other voluntary group who had indicated an interest in a voluntary grant were sent an application, to be returned by 31 December 2009.
- On 4 March Councillors M Ranson, R Sherras, S Hore, D Berryman acting as 2.5 substitute for A Knox met to consider the applications received.

ISSUES 3

- 3.1 The Council received 14 applications totalling over £159,954. The funds available were £91,560. The sub group considered each application in detail.
- 3.2 After careful consideration the sub group recommends the allocation of grants as shown at annex 1.
- 3.3 All funds have been allocated.
- 4 RECOMMENDATION
- 4.1 Approve the allocation of grants as proposed by the voluntary grant sub-group as set out in annex 1.
