1 PURPOSE

- 1.1 To inform Committee about changes in responsibilities for licensing following the Council's recent restructure and to ensure that the necessary delegations are in place to maximise flexibility within the section.

2 BACKGROUND

- 2.1 When the Licensing Committee was created, the Committee had responsibilities under the Licensing Act 2005.
- 2.2 The delegation of functions in respect of that Act was approved by Committee on 5 August 2004.
- 2.3 Subsequently, responsibility for taxi and private hire licensing was transferred to the Licensing Committee and the delegation scheme in respect of those responsibilities was approved by Committee on 12 June 2006.
- 2.4 Once the Council's restructure has taken effect, the legal services section will continue to provide the services covered by the two delegation schemes, and in addition will take on responsibility for licensing (liquor and entertainment) enforcement.
- 2.5 The licensing (liquor and entertainment enforcement) function is currently carried out within the environmental health section. The officer responsible has already assisted the legal services section by providing some licensing (private hire and taxi) enforcement.
- 2.6 There are therefore in existence two basic delegation schemes, to which additions have been made since 2006 eg in relation to the Gambling Act.
- 2.7 It is proposed that the most appropriate course of action when reviewing the delegation scheme would be to merge the two schemes, in order to ensure that all officers within the legal services section who carry out licensing duties are fully authorised to deal with both aspects of the Council's responsibilities, ie taxi and

- private hire and liquor and entertainment and to deal with applications and enforcement.
- 2.8 Attached as Appendix 1 is a suggested replacement, encapsulating the previous schemes.
