#### 1 PURPOSE

- 1.1 To consider and confirm the appointment of Dr Andrew Smith as the Council's Public Analyst, Food Examiner and Agricultural Analyst.
- 1.2 Relevance to the Council's ambitions and priorities:
  - Council Ambitions To help make peoples' lives safer and healthier. To protect and enhance the existing environmental quality of our area.
  - Community Objectives To promote and support health, environmental, economic and social wellbeing of people who live, work and visit the Ribble Valley.
  - Corporate Priorities To be a well-managed Council, providing efficient services based on identified customer needs.
  - Other Considerations To formally agree the necessary appointment of an officer to undertake essential services on behalf of the borough.

### 2 BACKGROUND

2.1 As a district council, Ribble Valley Borough Council is required to appoint and authorise a Public Analyst, Food Examiner and Agricultural Analyst to act on behalf of our authority.

### 3 ISSUES

- 3.1 I have received a letter from Lancashire County Laboratory advising of a change of personnel at the Public Analysts Laboratory in Preston. The letter advises of the recent appointment of Dr Andrew Smith, BSc, PHD, MMA, CSci, CChem and MRSC as the new Public Analyst, Food Examiner and Agricultural Analyst and asks for his ratification to act on behalf of the Council for relevant related matters.
- 3.2 In order for the Public Analyst to act on our behalf, it is necessary that he is formally accepted for that position and hence this report being brought to this Committee for consideration and ratification.
