1 PURPOSE

- 1.1 To determine the annual fees and charges for Scrap Metal Dealer's and Sex Establishment licences.
- 1.2 Relevance to the Council's ambitions and priorities

2 BACKGROUND

Scrap Metal Dealers Fees

- 2.1 Schedule 1 paragraph 6 of the Scrap Metal Dealers Act 2013 provides that "(1) An application must be accompanied by a fee set by the authority. (2) In setting a fee under the paragraph, the authority must have regard to any guidance issued from time to time by the Secretary of State with the approval of the Treasury".
- 2.2 On 17 September 2013, Committee considered the report of the Chief Executive, and approved the fees, which were to apply once the Scrap Metal Dealers Act 2013 came into force on 1 October 2013, in doing so Committee considered the calculation of the fees and the Home Office Guidance. The current fees are set out in Appendix 1 to this report.

Sex Establishments

- 2.3 Schedule 3, paragraph 19 of the Local Government (miscellaneous provisions) Act 1982 provides that "An applicant for the grant, [variation,] renewal or transfer of a licence under this Schedule shall pay a reasonable fee determined by the appropriate authority."
- 2.4 On 6 September 2011, Committee considered a report of the Council's solicitor and approved the fees set out as Appendix 2 of that report. Those remain the current fees and are set out in Appendix 2 of this report.

3 ISSUES

Scrap metal Dealers Fees

As detailed above the fees for Scrap Metal Dealers have only been in place for five months and in that time the Council has received just 7 applications for Scrap Metal Site and/or Collector's licences. Little has changed in the interim period and the Council does not yet have sufficient information upon which to review the basis of the calculation set out in the report dated 17 September 2014. It is therefore proposed that the fees should be set from 1 April 2014 to be the same as those in **Appendix 1**.

Sex Establishment Fees

3.2 Since the fees were set on 6 September 2011, the Council has not received any applications to licence a Sex Establishment within its area. There is therefore no information to suggest that the fees should change from those considered by Committee. It is therefore proposed that the fees should be set from 1 April 2014 as those contained at **Appendix 2** to this report.
