1 PURPOSE

- To advise the sub-committee on the determination of an application required under section 35 of the Licensing Act 2003.
- 1.2 Relevance to the Council's ambitions and priorities
 - Community Objectives]
 - Corporate Priorities

The Council aims to be a well managed Council; a robust licensing process contributes to that objective.

- Other Considerations
- 2 THE APPLICATION
- 2.1 The applicant, The Lower Buck Limited already has the benefit of a Premises Licence, originally granted on 27 September 2005 and transferred to the Lower Buck Limited on 8 September 2008. The licence currently permits a performance of live music and the supply of alcohol for consumption on and off the premises.
- 2.2 A copy of the existing licence is attached at Appendix A.
- The applicant has now made an application to vary the Premises Licence under Section 34 of the Licensing Act 2003. A copy of the application is attached at **Appendix B**.
- 2.4 Details of the licensable activities currently permitted, together with the variations applied for are set out in the table attached at **Appendix C**.
- 2.5 There are no additional measures described by the applicant at Section M "Licensing Objectives". These are as per the existing Premises Licence.
- 2.6 An additional condition has been agreed with the Police and the applicant's instructing solicitors in relation to "Challenge 25":
 - "A 'Challenge 25' scheme will be in operation. All persons who appear to be under the age of 25 years shall be required to produce proof of age by way of the following:
 - A recognised proof of age card accredited under the British Retail Consortiums Proof of Age Standards Scheme (PASS);
 - Photo driving licence;
 - Passport:
 - Official ID card issued by HM Forces or European Union Member State bearing a photograph and birth date of the holder.

All staff shall receive training to prevent under age sales of alcohol. All staff to receive regular refresher training to prevent underage sales."

- 2.7 There have been 10 relevant representations made. Relevant representations can be made in opposition to, or in support of, an application and can be made by any individual, body or business that has grounds to do so.
- 2.8 Statutory guidance states: "A representation is "relevant" if it relates to the likely effect of the grant of the licence on the promotion of at least one of the licensing objectives" and "representations should relate to the impact of licensable activities carried on from premises on the objectives."
- A copy of the representations are attached at **Appendix D** and are made on the basis that the application will undermine three of the licensing objectives, mainly relating to the prevention of crime and disorder, public nuisance, and public safety.
- 2.10 On 2 April 2015, the Applicant's Solicitors, Napthens LLP, held a mediation meeting with those persons who had concerns, in order to explain their client's intentions for the premises and to explore any ways in which these could be addressed to the satisfaction of all parties. A copy of the letter inviting persons to the meeting is attached at **Appendix E**.
- 2.11 A plan is attached at **Appendix F** showing the location of the premises.
- 2.12 All parties have been given notice of the hearing in accordance with Regulation 6 of The Licensing Act 2003 (Hearings) Regulations 2005.
- 3 THE LICENSING ACT 2003
- 3.1 When determining an application, the Licensing Act 2003 requires you to have regard to the representations received from Responsible Authorities and/or Other Persons (including supporting information), statutory Guidance issued under s.182 of the Act, the authority's Licensing Policy Statement and take such of the steps as you consider necessary for the promotion of the four licensing objectives i.e.
 - The prevention of crime and disorder:
 - Public safety;
 - The prevention of public nuisance; and
 - The protection of children from harm.
- 3.2 The steps you may take are set out at section 2 of the Licensing Hearings Guidance for Members, together with the statutory guidance issued under section 182 Licensing Act 2003 commencing at section 8.

ANNEX 1

MANDATORY LICENSING CONDITIONS

- 1. Section 19 of the Act provides that where a premises licence authorises the supply of alcohol, the licence must include the following conditions:
 - (1) No supply of alcohol may be made under the premises licence -
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence; or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
 - (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 2. Section 19A of the Act provides that where a premises licences authorises the supply of alcoholfor consumption on the premises, the licence must include the following conditions:
 - (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the

sale or supply of alcohol for consumption on the premises -

- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
 - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective:
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that (other than where that other person is unable to drink without assistance by reason of a disability).
- 3. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 4. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The Designated Premises Supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.

- 5. The responsible person must ensure that:
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25ml or 35ml; and
 - (iii) still wine in a glass: 125ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- 6. (1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
 - (2) For the purposes of the condition set out in paragraph (1) -
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
 - (b) "permitted price" is the price found by applying the formula $P = D + (D \times V)$ where -
 - (i) P is the permitted price,
 - (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
 - (iii) V is the rate of Value Added Tax chargeable in relation to the alcohol as if the Value Added Tax were charged on the date of the sale or supply of the alcohol:
 - (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
 - (i) the holder of the premises licence,
 - (ii) the Designated Premises Supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence:

- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "Value Added Tax" means Value Added Tax charged in accordance with the Value Added Tax Act 1994.
- (3) Where the permitted price given by Paragraph (b) of paragraph (2) would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (4) (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph (2) on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or Value Added Tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies or alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- Alcohol shall not be sold or supplied except during permitted hours.

In this condition, permitted hours means:

- a. On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day, which would be 11.00am if New Year's Day falls on a weekday or 12 noon if a Sunday.
- 8. In addition to the above hours, alcohol is permitted to be served and supplied as follows:
 - a. on 24th and 26th December from 1100 until 0000 the following day;
 - b. Easter and Bank Holiday Mondays from 1100 until 0000 the following day:
 - New Years Eve from 1100 on 31st December to 0130 the following day:
 - d. St Patricks and St Georges Day from 1100 until 0000 the following day.
- 9. In addition to the above opening hours, the premises is permitted to open as follows:
 - a. on 24th and 26th December from 1100 until 0030 the following day;
 - b. Easter and Bank Holiday Mondays from 1100 until 0030 the following day:
 - New Years Eve from 1100 on 31st December to 0200 the following day;
 - d. St Patricks and St Georges Day from 1100 until 0030 the following day.

ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

ON-LICENCE

- The above restrictions do not prohibit:
- a. consumption of the alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;
- b. the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- c. the sale of alcohol to a trader or club for the purposes of the trade or club;
- d. the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces:
- e. the taking of alcohol from the premises by a person residing there; or
- f. the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or
- g. the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.
- 2. The designated premises supervisor will be a member and active supporter/participant at the local pub watch scheme (where one exists).
- 3. There will be no irresponsible drink promotions which may encourage binge drinking.
- 4. All members of staff concerned with sales of alcohol will be trained in relation to sales of alcohol to persons under the age of 18 years.
- 5. A zero tolerance drugs policy is in place.
- A heat sensored light is positioned over the main entrance door and also on the car park for customer safety when exiting the premises.

- Emergency exits and emergency escape routes will be maintained to ensure that these can be used at all times.
- 8. Testing and inspection of the gas installation at the premises by a qualified engineer every 3 years.
- Testing and inspection of the emergency lighting at the premises by a qualified engineer every 3
 years.
- 10. Testing and inspection of the fire alarm at the premises by a qualified engineer every 3 years.
- 11. Testing and inspection of the electrical installation at the premises by a qualified engineer every 3 years.
- 12. All escape routes and exists will be maintained so as not to cause hindrance in the event of evacuation.
- 13. The premises will have agreed links with a local taxi company for collection of customers.
- 14. The beer garden will not be used for the consumption of alcohol after 2200hrs Sunday to Thursday and after 2300hrs on Fridays and Saturdays.
- 15. The management will ensure that the grounds of the premises will be kept tidy and without nuisance to other neighbouring businesses or residents.
- The licensee will monitor noise from regulated entertainment and take reasonable steps to ensure there is no disturbance to nearby residents.
- 17. Smoking only permitted in the snug and pool room and Beer Gardens.
- The cigarette machine at the premises is to be positioned within sight of the bar servery in order that full supervision can be given.
- 19. No persons under the age of 16 will be allowed on the premises after 2200hrs.





Re: Lower Buck P.H. Waddington - Licence Application

I refer to the above and herewith confirm my comments, observations and/or objections to the proposed application:

- 1. My property in which I have resided for 20myears is directly opposite the Lower Buck being only 2.6 metres distant ie corner of L.B. and W.E.L., Therefore it should be understood that any problems encountered are impossible to ignore.
- 2. The Lower Buck is a village pub and NOT a town centre or city pub where generally, there are no adjacent or nearby residential properties.
- 3. External lights have been left on throughout the night hence causing light nuisance to us one daughter;s bedroom is very close to the pub and one outside table.
- 4. Nuisance in the form of shouting/swearing/throwing bottles has already been experienced and the proposed licence extension until 01.30 will not be tolerated and therefore I object most strongly on this aspect.
- 5. Traffic movement taxis currently arrive and sometimes horns are used to alert persons in the pub, particulary when it is raining. Further, car doors are slammædd This is considered yet another nuisance which would become totally unacceptable for the extended opening hours.
- 6. Presence The previous landlod Andrew Warburton did not live on the premises during the c. 6 years tenancy. It is during this period that problems have become more frequent. However, I have not made aby objections to the problems experienced by us. It should be noted that during the time of the previous Landlord ie Mick no problems occured, this no doubt due to him living in the adjacent cottage. Such problems that did very occasionally occur were very quickly dealt with he was an extremely concientious landlod.
- 7. The extended hours could quite possibly lead to an influx of young drinkers coming in when the Clitheroe pubs close, to "enjoy" the ability to drink into the early hours; persons from the Edisford Bridge caravan site etc. will enjoy the extended drinking opportunities.
- 8. History 2 kitchen extract roof fans were installed c. 14 years ago without RVBC approval. Subsequently, one had to be removed due to excessive noise experienced by several properties behind the pub.



We are writing to strongly object to the application made by The Lower Buck, Waddington to extend their opening hours and to hold live music performances.


My husband and I live adjacent to the pub garden and as neighbours we tolerate the noise from the pub already which consists of a large external kitchen fan, customers swearing and shouting when leaving the premises late at night as well as raised voices whilst smoking outside. In addition there are occasional taxis who sound their horns past midnight when collecting customers rather than entering the pub. Extending the hours of business further into the early hours of the morning will only aggravate this nuisance.

The pub is in a country village and we think the hours and conditions they have at the moment are sufficient. We acknowledge and support the recently appointed manager in trying to rejuvenate the pub, however the leap from no music played (as is the case now) to live bands is disproportionate. Live music is occasionally played at their sister pub, the Waddington Arms, just 150 yards away and it can be heard all over the village. Live music at both venues is unwarranted.

We have invested in secondary glazing and keep our door closed due to the noise in order to live together but we are concerned that The Lower Buck is made up of several small rooms so when live loud music is on the customers will likely spill outside the pub therefore increasing the noise level. This is a particularly important consideration as a family with young children live within earshot of the smoking areas front and rear. The premises is in an old building, it was not designed to contain modern levels of sound and vibration, and that the noise will inevitably escape from the premises and affect us and other neighbours who are mostly retired.

The other main drawback of the pub is that it has very few parking places. If the live music is intended to draw new custom from further afield then customers will inevitably be parking cars and mini buses on the already crowded country lanes.

Customers will also have the ability to use the outside facilities such as the beer garden, which is situated right on the edge of Edisford road enabling the noise during the extended opening hours to escape out of the premises and affect the neighbouring properties causing a public nuisance.

My concerns relating to the noise that will be produced at the premises and the resulting public nuisance are increased by the application to extend the hours for performances of live music and to add the provision of recorded music at the premises. The present licence prevents the performance of live music past 11pm on Sundays to Thursdays and on Fridays and Saturdays live music must stop at midnight. Under the proposed variation live performances will be able to continue until 1am throughout the week. The loud music and vibrations from the live performances, and where there are no live performances the playing of recorded music, will affect all the homes within the vicinity of the premises during these unsociable hours.

Furthermore, by extending the hours for the supply of alcohol on and off the premises to 1100hrs – 0100hrs Monday to Sunday will provide customers with a place to consume alcohol over a large period of time the effect of which will result in drunkenness on and off the premises in an area which is surrounded by quiet residential homes. The extended hours for supplying alcohol will encourage anti-


social behaviour by providing a venue for excessive consumption of alcohol and the local community will have to endure the alcohol related problems which stem from such consumption such as shouting, noisy and potentially aggressive behaviour both at the premises and while customers make their way home.

For the reasons stated above I strongly object to the proposed variations to the licence of the Lower Buck Inn.

I refer to the above applications to vary the Premises Licence:

I presently live in the immediate vicinity of the Premises and have done since May 2009. I have lived in Waddington in the vicinity of the Premises for over15 years and know the village well.

I write to register my objection to the application for variation of the Premises Licence.

A. Extended hours for live and recorded music

Daily

11.00 - 1.00 daily

New Years' Eve

All night

(1) The prevention of crime and disorder

The present licence permits live and recorded music until 11.00 pm on Sunday to Thursday and midnight on Fridays and Saturdays. Extending the hours for live and recorded music will bring a greater concentration of young drinkers to the village without there being any measures to provide a safe and clean village.

The appeal to a younger customer is likely to lead to litter, disorder, and as there is no public transport available a greater likelihood of drink driving offences.

There is no Police presence in the village to prevent crime and disorder

(2) Public safety

There is no pavement or pedestrian protection along the road and customers are required to walk along the highway to gain access and for egress and are in danger from vehicles which drive though the village much faster at night.

(3) The prevention of public nuisance

Both live and recorded music will cause a public nuisance by way of noise escaping from the Premises which will be increased by extending the permitted hours.

Extending hours will cause a migration of customers though the village at late hours with the inevitable consequential noise and disturbance.

Extending hours will result in concentrations of young people in a small village which will produce disorder and disturbance. The need to disperse people quickly and safely from the centre of the village to avoid such concentrations cannot be fulfilled.

There is no Police presence in the village to prevent a public nuisance or to provide any enforcement.

B. Extended hours for supply of alcohol both on and off the Premises

Daily

11.00 - 1.00 daily

New Years' Eve

All night

(1) The prevention of crime and disorder

Extending late night drinking will increase the likelihood of drunkenness and alcohol related crimes.

(2) Public safety

Extending the licencing hours will exacerbate the existing problems in that the Premises are located on a tight S bend without views and customers being dropped off and collected in the early hours are in danger of being unseen by cars.

There is no pavement or pedestrian protection along the road and customers are required to walk along the highway to gain access and for egress and are in danger from vehicles which drive though the village much faster at night.

The street lighting is poor and pedestrians cannot be seen by vehicles

(3) The prevention of public nuisance

The Premises are located within a small area of residential accommodation in which there exist 3 public houses drawing customers from the local area all of which travel by car as there is no public transport facility. Extending the hours will increase nuisance from customers leaving the Premises in terms of voices, car door slamming and car engines.

Lower Buck Waddington Licence Extension Application

We live immediately behind the Lower Buck a few yards from the back gates. Our bedroom overlooks the lane. We strongly oppose the application to extend their hours.

- 1. The Lower Buck is a village pub with no car parking. Cars therefore park on the street which is limited and has no pavements for pedestrians. So the space left for the movement of people and cars is very limited. There is also a right angle bend on the gable end making it very dangerous for pedestrians and the many cyclists who use it.
- 2. Street lighting is limited.
- 3. There is a lot of drinking outside the pub, including the yard at the back. We experience shouting and bad language and often children are present or live close by. But this ends round about 11.30pm. The proposed extension to 01.30am would make this unbearable and therefore strongly object to it.
- 4. Live and Recorded music till 01.30am would add to the problems.
- 5. There is quite a lot of noise when car doors are slammed and engines start. Also taxis sometimes blow their horns when collecting passengers. This would become intolerable if the hours were extended to 01.30.am
- 6. With limited on street parking customers do park at times behind the Lower Buck and this makes getting in and out of the lane tricky; sometimes cars are left overnight. It is impossible for larger emergency vehicles to get by.
- 7. The proposed extension of hours would lead to an influx of drinkers including younger people into Waddington from Clitheroe after their pubs have closed.
- 8. There is no Police presence in the village and no one lives at the Lower Buck.
- 9. About 14 years ago 2 kitchen extract fans were installed through the roof without RVBC approval. Subsequently one had to be removed due to the excessive noise experienced by several properties at the rear of the Lower Buck. There was also a restriction on the use of the fan as it is still noisy but this has been completely ignored. If an extension were to be granted the fan would be left running until closing.
- 10. We understand that the application states that further licence revisions would be applied for, what are these?

We would be grateful if you would give the above points your serious consideration.



There has been no landlord or Managet etc. living in residence during the past c 6 years and therefore no control. Further, there is no police presence in the village






