#### 2 BACKGROUND

- 2.1 A report was brought to this committee on 17 March 2015, which highlighted issues which had been raised regarding the removal of the temporary licence for private hire drivers. Following public participation at committee it became clear that the issue arose more particularly from the need to complete the Steering to Success course before a licence was issued for both private hire vehicle drivers and hackney carriage vehicle drivers. Committee therefore resolved to establish a working group which would consider the content and organisation of the Steering to Success course and report back to this committee. The Head of Legal and Democratic services was also authorised to consult licence holders in advance of this meeting.
- 2.2 Licence holders were consulted upon their views on the steering to success course. The consultation documents are enclosed with this report as **Appendix 1** and the responses received to the consultation are enclosed in tabular form as **Appendix 2**.
- 2.3 A working group was established made up of the Chair and Vice Chair of this committee and Councillor Brunskill. The working group met twice on 14 May 2015 and 11 June 2011. It considered what arrangements were in place in the surrounding authorities as well as the views of licence holders express at committee and in the consultation. A table detailing the various requirement of surrounding authorities is enclosed as Appendix 3, as are details of the course content for the Steering to Success course, the DVSA taxi driving test and the Edexcel, Level 2 NVQ in Road Passenger Vehicle Driving (Taxi and Private Hire) ("NVQ"). The course content for the NVQ is lengthy and so only the content page has been included in hard copv. #### 3 ISSUES

- 3.1 There were 5 responses to the consultation. 1 response stated that they felt that the steering to success course was more than adequate; another considered that it was a good idea for new badges. The other 3 responses were critical of the course and in particular noted:
  - •The emphasis on English and maths rather than private hire issues;
  - •There can potentially be a 6 month delay in being able to start and complete the course due to the arrangements at the college;
  - •There should be an exemption from those who already have public service vehicle licences:
  - •There should be an assessment of a driver's ability behind the wheel;
  - •The course should be at the driver's own expense not tax payers; and
  - •Any replacement course should include:
    - Oriver assessment
    - oPractical guidance on disabled passengers
    - oBasic vehicle maintenance
    - OMotoring law
    - oMaths/English test with preparation in user's own time.
- 3.2 The working group considered the alternatives to the steering to success course, the comments made at the meeting on 17 March 2015 and during its consultation and recommends that the Council remove the requirement for the steering to success course to be passed before a licence be issued. This will be replaced by a requirement that all applicants provide evidence that they have passed the DVSA taxi driving test before a licence is issued and a requirement that an applicant complete and pass the NVQ within 12 months of the licence being issued. Should this not be the case the licence would not be renewed.
- 3.3 The working group felt that this would address the concerns expressed by licence holders: it would provide a practical driving and wheel chair assessment prior to issue of a licence; requires a higher level of maths and English (with applicant's being referred for separate literacy and numeracy course if they are not able to achieve the required level at initial assessment) includes more detailed knowledge of disability issues, is a national qualification which is transferrable and is more widely available; contains assessment on safety requirements and maintenance of the vehicle; and assessment on knowledge of the legislation applicable to private hire and hackney carriage drivers, operators and vehicles.

# Ribble Valley Borough Council Potential changes to Disclosure and Barring Service, the introduction of an additional check on drivers licences and the associated costs

The Council's Licensing Committee discussed these matters on 17 March 2015. Committee was informed that it was possible that the Council's status as a registered body for the DBS service may be withdrawn in the future and the Council needed to make arrangements should this occur. It was proposed that this be through use of a service provider to process the DBS checks on behalf of the Council and that this would have an additional cost of approximately £10, the cost to be borne by licence holders.

Committee was also informed that from 8 June 2015 the paper counterpart of driving licences would no longer be valid and that the DVLA would no longer issue these. Committee considered the introduction of additional checks to be carried out on driver's licences to validate the information which would otherwise have been available in the counterpart licence. This would have an associated cost of £5 which it is proposed should be met by licence holders.

The Council's Licensing Committee has therefore decided to consult upon these issues.

The Council is also considering the relative merits of the Steering to Success Course and whether there are possible alternatives. If you have any views upon this or any information on possible alternatives, these are welcomed by the Council.

### **Timetable**

The next meeting of the Council's Licensing Committee will be held on 23 June 2015. It is proposed that the results of this consultation will be reported to that Committee. The Consultation will therefore run from 14 May 2015 to 9 June 2015.

More details on the above proposals can be found in the Committee report available on request or via the Council's website.

Comment	Certainly a good idea for prospective new badges.
Comment	I feel that the S.S course is more than adequate.
Comment	The Steering to Success Course is, in my view, largely a waste of the driver's time and council-taxpayers money.
	There are two useful elements to it:
	<ul> <li>Basic vehicle maintenance</li> <li>Practical guidance on disabled passengers</li> </ul>
	Each of these sessions lasted for one evening of 2-3 hours, from a total of I think 9 sessions.
	Several sessions were devoted mainly to basic maths and English. These are clearly important to provide a good service to fare-paying passengers, but for this to be the bulk of the contact time at ACROSS was completely unnecessary for more than half of those present – irrespective of ethnic background.
	Of the remainder, the session involving the Police was all around being 'eyes and ears' for them to help combat crime, and more particularly terrorism. I have no issue with doing that, and think most of the public would agree, but I had expect more on the subject of motoring laws, and safe driving techniques.

This brings me to the huge omission of Steering to Success. Given that the role is driving the public at all hours of the day or night, and often involving long distances on all sorts of roads, there is no assessment of the driver's ability behind the wheel. Surely, this can't be right.


Finally, I also feel that courses of this nature should be at the user's expense, not the council tax-payer. Equivalent 'qualifications' for LGV or PCV licence would be at the user's expense and this should be too.

So far I have just dismissed the value of the current course. If it is to be replaced, I think the key elements should be:

- Driver assessment a RoSPA course or something similar
- Practical guidance on disabled passengers
- Basic vehicle maintenance
- Motoring law with particular regard to hackney and private-hire vehicles (including minibuses)
- Maths and English test (with preparation in user's own time)......

### DVSA taxi driving test

You might need to pass the Driver and Vehicle Standards Agency (DVSA) tax assessment to drive a taxi or private hire vehicle (PHV) - contact your local council to find out if you need to.

There are 3 types of assessment you can take:

- · the standard driving assessment
- · the enhanced assessment this includes a wheelchair exercise
- the upgrade assessment if you've done the standard assessment and now want to do the wheelchair exercise

### Book your test

- Contact your local council (https://www.gov.uk/find-your-local-council) to find out if you need to take the test.
- Book your test (https://www.gov.uk/book-practical-driving-test) with DVSA if you have to take it.

### What the assessment involves

The assessment lasts for about 40 minutes.

### Eyesight test

At the start, you'll have to read a number plate from a distance of:

- · 20 metres for vehicles with a new-style number plate
- · 20.5 metres for vehicles with an old-style number plate
  - New-style number plates start with 2 letters followed by 2 numbers, eg AB51 ABC.

You must use glasses or contact lenses during the whole test if you need them to read the number plate.

You can't take the driving part of the assessment if you fail the eyesight test. You can still do the wheelchair exercise if you're taking the enhanced assessment.

### Practical assessment

The assessment will include:

- a manoeuvre where you'll be asked to turn your vehicle to face the opposite direction
- around 10 minutes of driving without being given turn-by-turn directions by the examiner
- stops at the side of the road as if a passenger is getting in or out /
- related questions, eg what to do if a passenger leaves property in your vehicle
- questions from the Highway Code (https://www.gov.uk/highway-code) and identifying traffic signs and road markings

You might also be asked to do an emergency stop.

You'll pass the assessment if you make 9 faults or fewer. You'll fail if you make a serious or dangerous fault.

#### Wheelchair exercise

You'll have to do a wheel chair exercise if you're taking the enhanced assessment - you'll need to bring a wheelchair accessible vehicle.

You'll need to show your ability to:

- safely load and unload the wheelchair in your vehicle
- use the wheelchair brakes to secure and release it
- · fasten the seat belts or safety harness
- secure any wheel belts or clamps fitted to your vehicle

### Vehicle requirements

Your vehicle must meet the same requirements as the car practical driving test (https://www.gov.uk/practical driving-test-for-cars/rules-for-cars-used-for-driving-tests), except it can't have L-plates ('L' or 'D' plates in Wales).

You're allowed to use a hire car to take the test.

If it has a private hire plate, the number must be the same as on the plate inside the vehicle.

It must also be wheelchair accessible if you're taking the enhanced test (eg London-style 'black cabs').

### Documents you must bring

You must bring your driving licence.

If you have an old-style paper licence instead of a photocard, you must also bring a valid passport.

### Passing the assessment

When you pass your taxi assessment, you'll get:

- a pass certificate (form TPH10)
- a copy of your assessment
- · a debrief from the examiner

When you pass your wheelchair assessment, you'll get:

- a pass certificate (form WTA10)
- · a copy of your assessment
- · a debrief from the examiner

Your local council will tell you what to do when you've passed the assessment

### Failing the assessment

If you fail the assessment you'll get:

- · a debrief from the examiner
- · a copy of your assessment
  - ! You must wait at least 3 clear working days before you retake the assessment. Sundays and public holidays don't count as working days.
