### 2 BACKGROUND

- 2.1 The Gambling Act 2005 (the "**Act**") gave the Council responsibility for licensing a variety of types of premises, for example betting offices and arcades. There are very few premises in the Council's area, which hold such licences, however, many premises licensed under the Licensing Act 2003 also hold permits under the Act for gaming machines.
- 2.2 The Act requires Councils to have a gambling statement of principles, to publish it every three years and to review it from time to time. The Council's revised statement is required to be in place by January 2016.
- 2.3 On 15 September 2015, the Council's Licensing Committee reviewed the Council's Statement of Principles on Gambling as required by the Gambling Act 2005. A copy of the policy is enclosed as **Appendix 1**.
- 2.4 The statement was approved by Committee to form the basis of a consultation exercise. The Act and best practice guidance require that a 12 week consultation take place. The consultation concluded on 9 December 2015.
- 2.5 At the date of this report the Council had received one response from those consulted. A copy of that response is enclosed as **Appendix 2**. If any further responses are received before the consultation closes they will be reported to Council at the meeting.

- 3 ISSUES
- 3.1 Three issues are raised in on page 5 the response contained at Appendix 2. The Council considers that these are an interpretation of the policy and are simply a restatement of the statutory position which would be taken into account by any Officer or Sub-committee considering a matter. It is not proposed therefore to amend the policy.
