1 PURPOSE

- 1.1 To update Committee on the availability of funding to deliver an affordable warmth programme in the borough for winter 2016/2017.
- 1.2 Relevance to the Council's ambitions and priorities
 - Community Objectives –

2 BACKGROUND

2.1 A bid to Lancashire County Council green energy fund for domestic energy efficient measures across Lancashire was approved in September 2016. This bid will provide £1 million pounds of funding over the next two years for measures to be targeted through an affordable warmth programme, to be delivered in each borough across Lancashire. The funding is to be distributed as set out in Appendix 1 of the report. The allocation will be made on a 60-40% payment split. The final 40% payment will be made dependent on the first 50% of the grant being committed.

3 ISSUES

- 3.1 LCC have specified that the grant expenditure is subject to an intervention list which sets out the measures that can be included. This list is focused on physical measures of improvement and a copy of the list is set out at Appendix 2. LCC have also set the eligibility criteria for the grant funding which is set out at Appendix 3.
- 3.2 The final guidance from LCC is due to be released later in October. Therefore, the grant policy will need to reflect the specified intervention and eligibility guidance provided by LCC.

DRAFT Interventions list

- Servicing, repairs and replacement boilers and heating systems and associated works, including controls
- Repairs to and new radiators and radiator reflectors
- Gas fire services and repairs
- draught proofing
- Standard loft and cavity wall insulation
- Interventions for 'hard to treat' cavities and solid walls such as non-standard insulation solutions and external or internal wall insulation.
- Glazing improvements

Advice can be provided if it relates directly to the physical measure being provided to the same household. E.g. advice on thermostatic controls where a new boiler has been fitted.

DRAFT Eligibility Criteria

Households will be eligible for funding if they meet at least one of the following health vulnerabilities:

- people with cardiovascular conditions
- people with respiratory conditions (in particular, chronic obstructive pulmonary disease and childhood asthma)
- people with mental health conditions
- people with disabilities
- older people (65 and older)
- households with young children (from new-born to school age)
- pregnant women

Additionally the NICE guidance highlights that living in a cold home may have a greater effect on people who have to spend longer than an average amount of time at home. This could include those with chronic health conditions, including terminal illnesses.

AND Issues of affordability / low income are present

Confirmed by:

• Someone being in receipt of means tested benefits

Or

 the CSE fuel poverty calculator being completed – must be completed where a single property is receiving more than £1,000

Or

• A 'declaration' by the Local Authority or health / social care professional that affordability issues are present.

Confirmation of what the health and affordability need is should be recorded in the monitoring returns, any evidence should be retained locally.

Districts will need to manage demand to direct the resource at those most in need. Districts may choose not to open up all the health vulnerability categories to self-referrals, instead restricting interventions for some groups to referrals from social care, and health partners or where their own service has identified a health and affordability vulnerability.
