1 PURPOSE

1.1 The purpose of this report is to ask Committee to approve, in principle, the proposal to make public spaces protection orders in respect of dog control (including dog fouling, dog exclusion and dogs on leads requirements) within Ribble Valley, and to authorise officers to publicise the proposed orders and to consult, as required by the Anti-Social Behaviour, Crime and Policing Act 2014.

1.2 Relevance to the Council's ambitions and priorities:

- Community Objectives - } To make people's lives safer and healthier and to
- Corporate Priorities - } protect and enhance the existing environmental
- Other Considerations - } quality of the area.

2 BACKGROUND

2.1 Dog Control Orders were made by Ribble Valley Borough Council in August 2014 and created offences of:

- failing to remove dog faeces;
- not keeping a dog on a lead in designated areas;
- not putting, and keeping, a dog on a lead when directed to do so by an authorised officer;
- permitting a dog to enter land from which dogs are excluded; and
- maximum number of dogs with any person (4).

2.2. The introduction of Dog Control Orders created transparency and consistency within the Council boundary and gave authorised officers the ability to issue Fixed Penalty Notices for offences that were previously not enforced. The power for local authorities to make Dog Control Orders was granted under the Clean Neighbourhoods and Environment Act 2005.

2.3 The Council currently has authorised officers who undertake public realm education and enforcement, including around responsible dog ownership, in line with the Council's Enforcement Policy. Enforcement action for environmental crime is either taken under current legislation.

2.4 The Council undertook a Public Space Protection Order pre-consultation questionnaire that was sent out to sports groups, schools and Parish and Town Councils to establish the baseline for the consultation questions. A copy of the pre-

consultation questionnaire is included as Appendix A with the summary of the results that were found and comments that were made. This concluded in summary that the Dog Control Orders are commonly known throughout the borough, however a large proportion of the respondents did not know if the powers had assisted the Council in the control of dogs. A large proportion of the respondents concluded that changes to the existing Dog Control Orders into the form of PSPO's allowed a review to be undertaken and additional changes to be made.

- 2.5 The penalty for committing an offence contained in a Dog Control Order is a maximum fine of level 3 on the standard scale (currently £1000). Alternatively the opportunity to pay a fixed penalty (currently £75) is offered in place of prosecution. A fixed penalty notice (FPN) is an 'on the spot' fine for committing criminal offences such as breach of Dog Control Orders. Payment of a FPN means that no further action will be taken for that particular offence, it doesn't constitute an admission of guilt by the offender, but it does mean that such cases are diverted away from the Magistrates Court which may lead to the court imposing a larger penalty of up to £1000 and a criminal record.

3 TRANSITION FROM DOG CONTROL ORDERS

- 3.1 Where a Dog Control Order is currently in force, it will continue to be valid for a period of three years following commencement of the Anti- social, Crime and Policing Act 2014. At this point it then is to be adopted and treated as a PSPO (with effect from October 2017).
- 3.2 Home Office guidance has identified that there is not the need to wait for this to happen and local authorities can decide to review the need for orders ahead of the transition. The Council has opted to review current areas of dog control ahead of October 2017, as an early review will allow for new areas of dog control to be considered and consulted on, for public spaces protection order signage requirements to be reviewed and for a smooth transition that allows fixed penalties to continue to be issued for those that breach orders.

4. ANTI-SOCIAL BEHAVIOUR, CRIME AND POLICING ACT 2014 – PUBLIC SPACES PROTECTION ORDERS

- 4.1 Section 59 of the Anti-social Behaviour, Crime and Policing Act 2014 gives the Council new powers to make public spaces protection orders (PSPOs). These orders are intended to deal with a nuisance or problem in a particular area that is detrimental to the local community's quality of life, by imposing conditions on the use of the area. They are designed to ensure that the law-abiding majority can use and enjoy public spaces, safe from anti-social behaviour.
- 4.2 The definition of public space is wide and includes any place to which the public or any section of the public has access, on payment or otherwise, as of right or by virtue of express or implied permission.
- 4.3 The Council can make a public spaces protection order if satisfied on reasonable grounds that two conditions are met. The first condition is that:
- a. activities carried on in a public place within the Council's area have had a detrimental effect on the quality of life of those in the locality; or
 - b. it is likely that activities will be carried on in a public place within that area and that they will have such an effect.
- 4.4 The second condition is that the effect or likely effect, of the activities:

- a. Is or is likely to be, of a persistent or continuing nature.
 - b. Is, or is likely to be, such as to make the activities unreasonable.
 - c. Justifies the restrictions imposed by the notice.
- 4.5 A public spaces protection order is an order that identifies the public place and:
- a. prohibits specified things being done in that public place;
 - b. requires specified things to be done by persons carrying on specified activities in that place; or
 - c. does both of those things.
- 4.6 The only prohibitions or requirements that may be imposed are ones that are reasonable to impose in order to prevent or reduce the risk of the detrimental effect continuing, occurring or recurring.
- 4.7 Prohibitions can apply to all persons, or only to persons in specified categories, or to all persons except those in specified categories.
- 4.8 The order can specify the times at which it applies and the circumstances in which it applies or does not apply.
- 4.9 Unless extended the order may not have effect for more than 3 years.
- 4.10 Before making a public spaces protection order, the Council must consult with the Chief Officer of Police, the local policing body, whatever community representatives the Council thinks appropriate to consult and the owner or occupier of land within the restricted area.
- 4.11 In deciding whether to make a public spaces protection order and if so, what it should include, the Council must have particular regard to the rights of freedom of expression and freedom of assembly set out in articles 10 and 11 of the European Convention on Human Rights
- 4.12 The Council must publish the text of a proposed order on its website.
5. PROPOSED DOG CONTROL PUBLIC SPACES PROTECTION ORDER
- 5.1 There are a number of differences between Dog Control Orders and the Public spaces protection orders, which are:
- a. the test for making a PSPO covers the same activities previously prohibited under DCOs, but also provides flexibility for local authorities to vary them as necessary;
 - b. multiple orders are replaced by a single order, thereby streamlining the process for making orders;
 - c. A PSPO continues to allow for the same type of restrictions set out in Dog Control Orders, but allows the local authority to be more flexible when responding to local problems;
 - d. PSPOs can be used to place restrictions on public rights of way, including the highways which could not previously be applied

- 5.2 The proposed dog control PSPO consultation is set out in Appendix B. It is proposed that the following PSPOs are considered through the consultation process:
- a. Introduction of a requirement to carry bags or other suitable means for the disposal of dog faeces.
 - b. The Fouling of Land by Dogs (Ribble Valley) Order 2014 is maintained and created into a PSPO.
 - c. Increase the fixed penalty fine to the maximum permitted.
 - d. The Dogs on Leads (Ribble Valley) Order 2014 made it an offence if the dog in your charge is not a lead in a designated area, being Clitheroe Cemetery. It is proposed that this be extended to introduce a requirement that dogs are kept on leads on all public roads, pavements and Council owned land (see Appendix C).
 - e. The conversion of the Dogs on Leads by Direction (Ribble Valley) Order 2014 into a PSPO.
 - f. The Dogs Exclusion (Ribble Valley) Order 2014 is created into a PSPO and is extended to include churchyards and all Town Council and Parish Council owned play areas (See Appendix D & E).
 - g. The Dogs (Specified Maximum) (Ribble Valley) Order 2014 is converted to a PSPO making it an offence for a person to take more than 4 dogs on to any land within the administrative area of the Ribble Valley.
- 5.3 Currently the Council's Dog Control Orders for clearing up dog faeces (ie dog fouling) and dog exclusion areas do not apply to all people.
- 5.4 Dog fouling is not required to be cleared by people who are:
- a. registered as a blind person in a register compiled under section 29 of the National Assistance Act 1948; or
 - b. have a disability which affects the person's mobility, manual dexterity, physical coordination or ability to lift, carry or otherwise move everyday objects, in respect of a dog trained by a prescribed charity and upon which the person relies for assistance.
- 5.5 Dog exclusion areas are not required to be complied with by people who are:
- a. registered as a blind person in a register compiled under section 29 of the National Assistance Act 1948; or
 - b. are deaf, in respect of a dog trained by Hearing Dogs for Deaf People (registered charity number 293358) and upon which the person relies for assistance; or
 - c. have disability which affects the person's mobility, manual dexterity, physical coordination or ability to lift, carry or otherwise move everyday objects, in respect of a dog trained by a prescribed charity and upon which the person relies for assistance
- 5.6 It is proposed that the same exemptions, as above, are created within the proposed new Dog Control PSPO to ensure that the restrictions placed on dog owners /

handlers are reasonable and take into account conditions where it is not possible to comply.

6. CONSULTATION

6.1 In accordance with the Anti-social Behaviour, Crime and Policing Act 2014, if a PSPO is approved in principle the Council is then required to consult the Chief Officer of Police, the local policing body, and appropriate community representatives.

6.2 In addition, Government guidance recommends that a community survey is undertaken to see if people support the introduction of the proposed PSPO. Subject to the Council approving the principle of the proposed PSPO, it is recommended that a community survey be undertaken using the Council website to run from June to August 2017 asking people if they would support the introduction of the proposed PSPOs.

6.3 In addition to Ribble Valley Borough Council residents, visitors and businesses it is recommended that the following specific stakeholder groups should also be consulted:

- All residents groups / associations near to proposed PSPOs.
- Ward Councillors.
- Friends of Groups for land subject to proposed PSPOs.
- Chair of the Parishes Committee.
- Dog welfare organisations including Wood Green, the RSPCA and the Dogs Trust.
- Organisations associated with assistance dogs including Guide Dogs for the Blind.

7. FINANCIAL IMPLICATIONS

7.1 In accordance with Anti-social Behaviour, Crime and Policing Act 2014, once a public space protection order is agreed, the Council must 'cause to be erected on or adjacent to the land in relation to which the public spaces protection order has been made such notice or notices as it considers sufficient to draw the attention of any member of the public using that land to:

- (i) the fact that a public spaces protection order has been made; and
- (ii) the effect of that order being made.

7.2 Consequently, there will be a financial cost to introducing the proposed order which will need to be met, either at the time the order is agreed, or by 20 October 2017 (after this time Dog Control Orders automatically become PSPOs and the requirement to change signage will apply). Approximately the total cost is in the region of £1,500 which will be met from within existing departmental cost centres.

7.4 The issuing of Fixed Penalty Notices will generate additional income, which can offset the cost of signage in future years if considered appropriate.

8. STAFFING IMPLICATIONS

8.1 There are no additional staffing implications as officers are already equipped to deal with dog fouling and nuisances.

8.2 The impact on residents, visitors and businesses is expected to be positive, as these proposals should continue to act as a deterrent to irresponsible dog ownership. Exemptions are currently in place for those with disabilities and it is recommended that the same exemptions are considered in the proposed public spaces protection order. There is no adverse impact on any other Protected Groups from its adoption.

9. ENVIRONMENTAL IMPLICATIONS

9.1 There will continue to be a positive effect on local environmental quality with the conversion of Dog Control Orders to Public Space Protection Orders and the continued enforcement against dog fouling.

10. PROCUREMENT

10.1 Costs for the purchase of signage are estimated to be in the region of £1,000 and fall below the threshold of £3000 within the corporate procurement procedures. Therefore best value will be demonstrated by obtaining at least one written quotation.

11. CONSULTATION AND COMMUNICATION

11.1 The order will also be published on the website and social media. Further consultation will take place with the groups detailed in section 6.3.

12. COMMUNITY SAFETY

12.1 The introduction of the proposed public space protection order for dog control will continue to have a positive effect on Community Safety, reducing the risks associated with Toxocariasis and nuisance dogs.

13. HUMAN RIGHTS

13.1 In deciding whether to make a public space protection order and if so, what it should include, the Council must have particular regard to the rights of freedom of expression and freedom of assembly set out in articles 10 and 11 of the European Convention on Human Rights.

14. RISK ASSESSMENT

14.1 The approval of this report may have the following implications:

- Resources – The cost of implementing a Dog Control Order will include:
 - publishing a notice in the local press;
 - consulting with every other Authority that has powers to make an Order in the Borough (eg Parish Councils, Access Authority, Local Access Forum);
 - new signage;
 - officer time.
- Technical, Environmental and Legal – The establishment of a new PSPO is a formal legal process.

- Political – The recommendations in this report are an extension of principles already agreed by this Committee.
- Reputation – The new Order demonstrates that the Council is responding to the concerns of local residents regarding dog fouling.
- Equality & Diversity – The legislation make provision for guide dogs, assistance dogs and hearing dogs for the deaf and there are exemptions to these from the various Orders where appropriate.

15 RECOMMENDED THAT COMMITTEE

- 15.1 To approve, in principle, the proposal to make Public Spaces Protection Orders for dog control within Ribble Valley.
- 15.2 To authorise officers to publicise the proposed Orders and to carry out consultation as required by the Anti-Social Behaviour, Crime and Policing Act 2014.

DRAFT DOG CONTROL PUBLIC SPACE PROTECTION ORDER CONSULTATION

There are currently a number of dog control orders covering parts of the borough that require dogs to be held on leads or excluded. The new legislation under the Anti Social Behaviour, Crime and Policing Act 2014 allows for the introduction of Public Space Protection Orders PSPOs which offer a more effective way of enforcing dog control in the Ribble Valley.

As a result we seek your views on a number of draft proposals to implement PSPOs in areas across the borough to replace the existing dog control orders.

If PSPOs are implemented, the fixed penalty notice is recommended to be £100 paid. There are four types of order being proposed at various locations across the borough and we estimate the consultation should take 15-20 minutes of your time.

Proposal 1 – Dog Fouling

Current position – under The Fouling of Land by Dogs (Ribble Valley) Order 2014, if a dog defecates upon designated land and the owner fails to remove the deposit forthwith, that persons shall be guilty of an offence and a fixed penalty notice served.

Proposal – A PSPO, enabling enforcement via an FPN, to be paid within 7 days.

Support/Object

Proposal 2 – Dogs on Leads – Public Highways

Current position – there is currently no legal requirement for dogs to be kept on leads on public highways in the Ribble Valley.

Proposal – A PSPO, enabling enforcement via a FPN, requiring dogs to be kept on leads on local highways at all time. The public highway is an open ‘main road or thoroughfare, such as street, boulevard or parkway available to the public for travel or transportation’.

Support/Object

Proposal 3 - Dogs on Leads – Council Land

Current position – the Dogs on Leads (Ribble Valley) Order 2014 came into effect in 2014; this made it an offence if the dog in your charge is not on a lead in a designated area. The designated area being Clitheroe Cemetery.

P – A PSPO is adopted with the addition of all Council owned land.

Support/Object

Proposal 4 - Dogs on Leads by Direction

Current position – the effect of the Order is that it is an offence if a dog in your charge is not put and kept on a lead of more than 1 metre in length, when directed by an authorised officer.

Proposal – A PSPO to reiterate the commitment.

Support/Object

Proposal 5 - Number of Dogs

Current position – it is an offence to take more than 4 dogs on to any land with the administrative area of the Ribble Valley.

Proposal – A PSPO to reiterate the commitment.

Support/Object

Proposal 6 – Dog Exclusion Zones

Current position – there is currently under the dog control order a requirement for dogs to be excluded from churchyards.

Proposal – A PSPO, introducing that dogs are excluded from churchyards at all times.

Support/Object – no comment

Proposal 7 – Dog Exclusion Zones - Children’s Play Areas and Multi use Games Areas (does not include football pitches)

Current position – there are numerous signs around children’s play areas and multi use games areas such as tennis courts, basketball courts etc requiring dogs to be kept out and under the dog control order that is enforced.

Proposal – A PSPO, enabling enforcement via a FPN, excluding dogs from all children’s play areas and multi use games areas with the inclusion of Town Council and Parish Council owned land.
