1 PURPOSE

- 1.1 To seek Committee's approval of the introduction of DBS checks for Private Hire Operators.

2 BACKGROUND

- 2.1 Committee will be aware that enhanced Disclosure and Barring Service ("**DBS**) checks are requirement for all applicants for private hire and hackney carriage driver's licences. This is part of the criteria for assessing whether an applicant is a fit and proper person. Any convictions disclosed to the Council by the DBS are considered in light of the Council's Convictions Policy.
- 2.2 The Council does not currently carry out DBS checks in relation to Private Hire Operators but it is under a similar duty not to licence persons who are not fit and proper. Whilst operators do not necessarily have as much contact with the public as a driver they do deal with customers in the office when taking bookings; hold customers personal information and have control of which drivers and vehicles attend person's homes or carry children or vulnerable adults.

3 ISSUES

- 3.1 In January 2017 Committee considered a proposal for an enhanced DBS check to be introduced for Private Hire Operators and that it form part of the criteria of whether they are a fit and proper person to hold an Operator's licence. Any convictions disclosed would similarly be considered in light of the Council's convictions policy. Committee approved this in principle and authorised the Council's Head of Legal and Democratic Services to consult licence holders on the proposal.
- 3.2 On 21 February 2017, the Council's Solicitor wrote to all private hire operators to consult them upon this matter. A copy of the consultation documents is enclosed as Appendix 1 to this report. In response to the consultation the Council received 1 response which

was supportive of the proposal and stated "*Definitely! Think this should have been introduced a long time ago.*" It is therefore proposed that the proposal be implemented from 1 July 2017 to allow sufficient time for any consequential amendments to be made to the Council's policies and procedures.

Ribble Valley Borough Council Proposed revision of the Council's convictions policy relevant to Private Hire and Hackney Carriage Licence holders.

The Council's Licensing Committee discussed this matter on 31 January 2017. Committee was informed that:

- The Council does not currently carry out DBS checks in relation to Private Hire Operators but it is under a duty not to licence persons who are not fit and proper.
- Whilst operators do not necessarily have as much contact with the public as a driver they do deal with customers in the office when taking bookings; hold customers personal information and have control of which drivers and vehicles attend person's homes or carry children or vulnerable adults.
- It is proposed that the requirement to provide an enhanced DBS check be introduced for Private Hire Operators and that it form part of the criteria of whether they are a fit and proper person to hold an Operator's licence.
- Any convictions disclosed would similarly be considered in light of the Council's convictions policy.
- There would be an additional cost to those applying for an Operator's licence of £54 for the DBS check. This is a relatively modest increase in cost and would only need to be renewed every 3 years.
- Operators who already have an enhanced DBS check because they also hold a drivers licence would not be required to obtain a separate DBS check provided that the two run concurrently.

The Council's Licensing Committee resolved to consult upon this issue.

The Consultation will run from 21 February 2017 to 7 April 2017 and the results will then be reported to Committee.
