#### 1 PURPOSE

- 1.1 To advise the sub-committee on the determination of an application required under section 35 of the Licensing Act 2003.
- 1.2 Relevance to the Council's ambitions and priorities
  - Community Objectives 1
  - Corporate Priorities
- The Council aims to be a well-managed Council; a robust licensing process contributes to that objective.
- Other Considerations
- 2 THE APPLICATION
- 2.1 The applicants, Stuart Bernard Clark and Lesley Ann Clark, already have the benefit of a Premises Licence originally granted on 5 October 2005 and transferred to them on 23 January 2014. The licence currently permits films (B), indoor sporting event (C) live music (E) recorded music (F), performance of dance (G), late night refreshment (I) and the supply of alcohol for consumption on and off the premises (J).
- 2.2 A copy of the existing licence is attached at **Appendix A** (page 4).
- 2.3 The applicants have now made an application to vary the Premises Licence under Section 34 of the Licensing Act 2003. A copy of the application is attached at **Appendix B** (page 16).
- 2.4 Details of the licensable activities currently permitted, together with the variations applied for are set out in the table attached at **Appendix C** (page 37).
- 2.5 The applicant at Section M on page 31 describes the additional measures they intend to take to promote the four licensing objectives. These will become additional conditions of the licence if the variation is granted.
- 2.6 In addition the applicants have agreed to include the Challenge 25 conditions as requested by the Police. These conditions are set out at **Appendix D** (page 40).
- 2.7 There have been 4 relevant representations made. Relevant representations can be made in opposition to, or in support of, an application and can be made by any individual, body or business that has grounds to do so.
- 2.8 Statutory guidance states: "A representation is "relevant" if it relates to the likely effect of the grant of the licence on the promotion of at least one of the licensing objectives" and "representations should relate to the impact of licensable activities carried on from premises on the objectives."

- 2.9 A copy of the representations are attached at **Appendix E** (page 41) and are made on the basis that the application will undermine one of the licensing objectives, namely the prevention of public nuisance.
- 2.10 A plan is attached at Appendix F (page 48) showing the location of the premises.
- 2.11 All parties have been given notice of the hearing in accordance with Regulation 6 of The Licensing Act 2003 (Hearings) Regulations 2005.
- 3 THE LICENSING ACT 2003
- 3.1 When determining an application, the Licensing Act 2003 requires you to have regard to the representations received from Responsible Authorities and/or Other Persons (including supporting information), statutory Guidance issued under s.182 of the Act, the authority's Licensing Policy Statement and take such of the steps as you consider necessary for the promotion of the four licensing objectives i.e.
  - The prevention of crime and disorder;
  - Public safety:
  - The prevention of public nuisance; and
  - The protection of children from harm.
- 3.2 The steps you may take are set out at section 2 of the Licensing Hearings Guidance for Members, together with the statutory guidance issued under section 182 Licensing Act 2003 commencing at section 8.

#### **ANNEX 1**

#### MANDATORY LICENSING CONDITIONS

- 1. Section 19 of the Act provides that where a premises licence authorises the supply of alcohol, the licence must include the following conditions:
  - (1) No supply of alcohol may be made under the premises licence -
    - (a) at a time when there is no designated premises supervisor in respect of the premises licence; or
    - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
  - (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 2. Section 19A of the Act provides that where a premises licences authorises the supply of alcohol for consumption on the premises, the licence must include the following conditions:
  - (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises -
    - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to -
      - drink a quantity of alcohol within a time limit (other than to drink alcohol sold

or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that (other than where that other person is unable to drink without assistance by reason of a disability).
- 3. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 4. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The Designated Premises Supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -
    - (a) a holographic mark, or
    - (b) an ultraviolet feature.
- The responsible person must ensure that:
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:

- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25ml or 35ml; and
- (iii) still wine in a glass: 125ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- 6. (1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
  - (2) For the purposes of the condition set out in paragraph (1) -
    - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
    - (b) "permitted price" is the price found by applying the formula  $P = D + (D \times V)$  where -
      - (i) P is the permitted price.
      - (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
      - (iii) V is the rate of Value Added Tax chargeable in relation to the alcohol as if the Value Added Tax were charged on the date of the sale or supply of the alcohol:
    - (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
      - (i) the holder of the premises licence,
      - (ii) the Designated Premises Supervisor (if any) in respect of such a licence, or
      - the personal licence holder who makes or authorises a supply of alcohol under such a licence:
    - (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
    - (e) "Value Added Tax" means Value Added Tax charged in accordance with the Value

#### Added Tax Act 1994.

- (3) Where the permitted price given by Paragraph (b) of paragraph (2) would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (4) (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph (2) on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or Value Added Tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies or alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- 7. In addition to the above hours, the following conditions apply on New Years Eve:
  - i) alcohol is permitted to be sold and supplied from 10am on 31 December to terminal time on 1 January;
  - ii) regulated entertainment is permitted from 10am on 31 December to one hour before the terminal time for supply of alcohol on 1 January.
  - iii) late night refreshment is permitted from 11pm on 31 December until terminal time on 1 January;
  - iv) the hours the premises are open to the public are from 10am on 31 December until 30 minutes after the terminal time on 1 January.
- 8. Section 20 of the Act provides that where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film be restricted. The restriction must be in accordance with any recommendation made by the relevant film classification body or any recommendation made by the licensing authority.

### ANNEX 3 - CONDITIONS ATTACHED AFTER A HEARING BY THE LICENSING AUTHORITY

1. All external doors and windows will kept closed when regulated entertainment is being provided, except in the event of an emergency.

- 2. The Licence holder or his representative shall on every occasion the premises are used for regulated entertainment check external noise levels at regular intervals to ensure that sound levels are reasonable and not affecting noise sensitive premises. Appropriate steps should be taken to reduce the level of noise where it is likely to cause a disturbance to local residents. Where a complaint is made either to the management or via the Local Authority, a written record shall be made of those noise assessments in a log book for a period of three months following the complaint. The details recorded shall include the time and date of the checks, the person making them and the results, including any remedial action. This written log shall be available for inspection by the Local Authority.
- 3. There shall be visible and clear notices requiring customers to leave the premises and the area quietly, placed at all exits.
- 4. Refuse, ie bottle sorting/disposal, shall not take place outside between 10pm and 8am.
- Customers should be reminded to leave quietly by regular announcements from the DJ during entertainment events and by door supervisors or members of staff as they are leaving the premises.
- Outdoor areas such as beer gardens shall not be used after 10pm. (The Council would normally recommend that patrons are brought in from outdoor areas at 10pm to ensure that the impact on nearby residents is kept to a minimum). Supervision of such areas should be carried out on a regular basis and, if appropriate, action should be taken to ensure that no behaviour that may disturb neighbours is allowed in this area.
- The grounds of the premises shall be maintained in a tidy and litter free state.
- 8. No customers will be allowed to take open bottles, cans or glasses (either glass or plastic) off site. Any sales of alcohol specifically for off site consumption shall be sold in sealed containers.
- The Licensee should ensure that any odours generated on site do not affect nearby premises, by ensuring that extraction equipment is suitably located and maintained.
- The lights in the beer garden shall be turned off at 10pm.





    - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
    - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

Response requesting the Council not to approve the application to vary the premises licence

Annex 3 Condition 6 and Annex 3 Condition 10 for the Spread Eagle. Mellor Lane, Mellor BB2 7EG

We are the immediate next doors neighbours to the Spread Eagle our property runs parallel with the Spread Eagle along Saccary Lane. The application made by the landlords of the Spread Eagle to vary Annex 3 conditions 6 and 10 will severely impact the quiet enjoyment of our property and other residents by extending the period for use of the beer garden to 11pm at night. (see Appendix)

We believe the reason for the current application is because the landlords have failed to properly management the beer garden in accordance with the existing licence conditions. Those licence conditions were at the time of instigation some 10 years ago strongly supported by Diane Rice Head of Licensing and Linda Boyer Environmental health Officer at a Licensing Committee meeting. There has been no change to the circumstances to the beer garden since the conditions were included in the licence, in fact previous landlords Whitbread (who accepted the conditions) and M&B both saw no reason to seek a change to the licence conditions in any respect. It is only the current landlords failure to manage the beer garden in accordance with the existing licence conditions, and recent and past reports from ourselves to the Council's Licensing Department regarding the noise and failure to manage the beer garden in accordance with the licensing conditions, that has brought about this application to vary the licence conditions.

The existing Annex 3 Condition 6 actually has in parenthesis "(The Council would normally recommend that patrons are brought in from outdoor areas at 10pm to ensure that the impact on nearby residents is kept to a minimum)". On several occasions the landlords have not complied with this and it is clearly the Council's recommendation so as to ensure that residents have the quiet enjoyment of their homes, that residents should not be disturbed by the noise of people who become louder following prolonged drinking in the evening. The beer garden can seat up to 60 people even a single loud voice after 10pm, in this very quiet rural area, is amplified. On many occasions towards 10pm there has been over 20 people outside causing considerable noise. We and neighbours should be able to have windows open and not be disturbed by the noise from the beer garden.

The landlords also seek to remove their requirement to supervise the beer garden on a regular basis, the supervision is there to ensure that residents are not impacted by behaviour from their customers, and to allow residents quiet enjoyment of their homes. It clearly means by this application that the landlords are showing a blatant disregard for their neighbours quiet enjoyment

of their property and their only reason for this application is either for financial gain or an acknowledgement of their own inability to considerately manage the beer garden in accordance with the licence conditions. The request to remove supervision of the beer garden is a reckless disregard for neighbours enjoyment of their property as well as a disregard for the health and welfare of their neighbours. On numerous occasions because of the landlords failure to supervise the beer garden we have been unable to enjoy our garden and been unable to go to sleep because of the loud voices, swearing, etc from customers in the beer garden, this is particularly embarrassing when we have friends visit.

The landlords also seek to vary Annex 3 Condition 10 which requires the landlords to turn the beer garden lights off at 10pm. The reason this was included in the existing licence conditions was to ensure that customers were not encouraged to stay outside in the beer garden, with the lights left on as we have found the landlords do not remove people from the beer garden and do not supervise the beer garden as required by the licence.

The existing licence conditions are not onerous and require the landlords to actively manage the beer garden.

Regarding the use of the beer garden the landlords stop serving food after 8.30pm Monday to Thursday, 9pm Friday and Saturday and 7.30pm on Sunday and therefore after 9pm, 9.30pm and 8pm respectively the beer garden is only used for continued drinking by customers. As customers continue to drink their noise levels become louder and as this is a very rural area that sound travels. As the nearest neighbours we are particularly disturbed by such noise up to 10pm and have been disturbed by loud swearing and laughter, high pitched screams, shouting from groups of people both before and after 10pm when the landlords have failed to supervise the beer garden. To expect our family to have to wait until at least 11pm every would be detrimental to their health and well being.

Further the request to vary the time for the closure of the beer garden impacts 365 days of the year. Whilst use of the beer garden will be in warmer weather. These weather conditions are also the most favourable for noise transmission. This coincides with ourselves and neighbouring properties need to open windows for ventilation.

The nature of the noise from the beer garden e.g. laughter, shouting, multiple conversations is more intrusive than traffic noise which is very infrequent late at night. The area is very rural and little or no sound is heard after 8pm at night from traffic. The Spread Eagle is the sole source of noise to residents in the area other than traffic.

The extension from 10pm to 11pm is at a time when ourselves and other residents are retiring to bed to sleep. Open windows in bedrooms for ventilation will allow the noise intrusion from the beer garden. We have 3 bedrooms in use and therefore the noise will impact the quiet enjoyment of our home after 10pm and that of other nearby residents. We believe it is unreasonable to expect ourselves to wait to go bed until 11pm or later as is likely to happen.

The wall around the beer garden does not afford noise reduction to our bedrooms which are above the height of the wall. Our house is elevated and therefore our bedrooms do not receive any protection to noise from the beer garden at night. Noise reflects off of the surrounding brick structures which adds to the sound travelling towards our property and bedroom windows.

Our other next door neighbours (Mr and Mrs Bateson) are in their late eighties, and not well, it is important that they are also afforded the quiet enjoyment of their property and the current conditions in the licence affords them and us that protection.

If the new variations are allowed to Annex 3 conditions 6 and 10 the landlords will have no obligation to supervise the beer garden at all at any time, it is highly likely that the landlords will not

enforce the 11pm closure, lights will remain on encouraging customers to stay in the area beyond 11pm, drinking and extending the noise issues for ourselves and other residents.

We therefore request that the Council follows its own recommendations set out in the existing licence at Annex 3 condition 6. That it rejects the variations requested to Annex 3 conditions 6 and 10. The Council supported the existing conditions in committee supported by Environmental Health and Licensing. There is no compelling reasons or evidence to support the requirement for such variations to the licence conditions. In fact such changes will have a serious impact on ourselves and other residents if allowed by the removal of supervision of the beer garden, extension to 11pm and not switching off the lights to the beer garden which actively encourages customers to remain in the beer garden. We believe that application is contrary to the expectation that neighbours have for the quiet enjoyment of their property as well as detrimental to the health and well being of our family and neighbours.



We are near neighbours to the Spread Eagle public house. We understand that the landlords of the Spread Eagle have made an application to extend the opening time for the beer garden from 10pm to 11pm and to remove the requirements to supervise outdoor areas.

We strongly object to the application because this will impact on the quiet enjoyment of our property. The area we live in is very quiet late in the evening and there is little or no traffic. Therefore any noises from the Spread Eagle such as loud voices swearing and screaming as people drink more alcohol outside is heard by us and can disturb our sleep, particularly when we have our windows open. We believe 10pm is late to close the beer garden but accept that is the existing licence condition however to extend the closure of the beer garden to 11pm would impact on our ability to go to bed at a reasonable time.

We also believe removing the requirement for the landlords to supervise outside areas at any time during the day 365 days of the year is unreasonable and will impact ourselves and other neighbours. This effectively does not require the landlords to manage the premises outside at all.

We respectfully request that the Council reject this application and maintain the existing licence conditions.
