

PUBLIC PATH DIVERSION ORDER

HIGHWAYS ACT 1980

RIBBLE VALLEY BOROUGH COUNCIL

DIVERSION OF PUBLIC FOOTPATH No.52 LONGRIDGE (PART)

This order is made by Ribble Valley Borough Council (the Authority) under Section 119 of the Highways Act 1980 (the 1980 Act) because it appears to the Authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the way should be diverted.

The applicant has agreed to defray any expenses, which are incurred in bringing the new site of the footpath into a fit condition for use by the public. All gates will be provided or modified so that they comply with BS 5907:2006.

BY THIS ORDER:

- 1. The public right of way over the land situated at Walton Fold, Longridge and shown by bold continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up as from the date the Authority certifies that all work to bring the footpath, as described in Part 2 of the schedule into a fit condition for use by the public has been carried out.
- 2. There shall at the end of 14 days from the date of confirmation of this order be a public footpath over the land situated at Walton Fold, Longridge described in Part 2 of the Schedule and shown by bold broken lines on the map attached to this order.
- 3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.



SCHEDULE

PART 1 DESCRIPTION OF SITE OF EXISTING PATH OR WAY

FOOTPATH 52.

From Ordnance Survey Grid Reference SD 6071 3662, Point A on the Order Plan in a generally easterly direction for approximately 142 metres to Ordnance Survey Grid Reference SD 6083 3665, Point B on the Order Plan and then in a generally east southeasterly direction for approximately 151 metres to Ordnance Survey Grid Reference SD 6098 3661, Point C on the Order Plan. The existing path is shown by a bold line on the Order Plan and marked A - B - C.

PART 2 DESCRIPTION OF SITE OF NEW PATH OR WAY

FOOTPATH 52.

The new length of path to be created being 2 metres wide commences from Ordnance Survey Grid Reference SD 6076 3657, Point D on the Order Plan in a generally east north-easterly direction for approximately 89 metres to Ordnance Survey Grid Reference SD 6084 3661, Point E on the Order Plan, and then in a generally easterly direction for approximately 133 metres to Ordnance Survey Grid Reference SD 6098 3661, Point C on the Order Plan, a total distance of approximately 222 metres. The new path is shown by a bold dashed line on the Order Plan and marked D - F - G - E - C.

PART 3 LIMITATIONS AND CONDITIONS

- 1. The right of the owner of the soil to erect and maintain a kissing gate to BS 5907:2006 at Ordnance Survey Grid Reference SD 6076 3657, Point D on the Order Plan.
- 2. The right of the owner of the soil to erect and maintain a 1.2 metres wide pedestrian gate to BS 5907:2006 at Ordnance Survey Grid Reference SD 6079 3658, Point F on the Order Plan.
- 4. The right of the owner of the soil to erect and maintain a kissing gate to BS 5907:2006 at Ordnance Survey Grid Reference SD 6084 3661, Point G on the Order Plan.
- 5. The right of the owner of the soil to erect and maintain a kissing gate to BS 5907:2006 at Ordnance Survey Grid Reference SD 6084 3661, Point E on the Order Plan.
- 6. The right of the owner of the soil to erect and maintain a kissing gate to BS 5907:2006 at Ordnance Survey Grid Reference SD 6098 3661, Point C on the Order Plan.
- 7. Installation of a reinforced grass system between Ordnance Survey Grid Reference SD 6076 3657, Point D on the Order Plan and Ordnance Survey Grid Reference SD 6084 3661, Point E on the Order Plan.
- 8. The length of path between Ordnance Survey Grid Reference SD 6076 3657, Point D on the Order Plan and Ordnance Survey Grid Reference SD 6084 3661, Point E on the Order Plan is cleared of a reasonable level of vegetation by the applicant and subsequent landowners.
