

SECTION 18 LICENSING ACT 2003 NOTICE OF DETERMINATION IN RESPECT OF A HEARING WHICH TOOK PLACE ON FRIDAY 26 JUNE 2015 TO DETERMINE AN APPLICATION BY FORUM WHALLEY LIMITED FOR A PREMISES LICENCE IN RESPECT OF 41 & 41A KING STREET, WHALLEY, CLITHEROE, BB7 9SP.

The Licensing Sub-Committee met on 26 June 2015. The Sub-Committee comprised the following members:

The Sub-Committee met to consider the application of Forum Whalley Limited for a premises licence.

The Sub-Committee considered the contents of the report of the Head of Legal and Democratic Services dated 26 June 2015 and its appendices ("**Report**").

Mr Livesey made verbal representations to the Sub-Committee through questions put to the Applicant. This highlighted the vision for the premises, the type of clientele, and the licensing history of the Applicant's other premises in Preston.

Representations were invited from:

Mr Wedgeworth, who stated that: he thought that the reality of the situation would be very
different from the way in which the Applicant had described it; an older clientele did not
necessarily mean there wouldn't be problems; and that Whalley was very different to
Preston he did not want a night time economy in Whalley.

- Councillor J Holgate who explained: that she received a lot of complaints about noise from late night licences and that the premises should have its windows shut with air conditioning to counter this; taxis were a problem in Whalley; and she was concerned that drinkers and smokers may be outside the front of the property on the narrow pavement.
- Councillor T Hill who stated: that he wanted to correct the impression that a high class venue wasn't welcomed in Whalley but he thought the hours applied for were too long and too late.
- Mrs L Luckin who noted that: she was not totally opposed to the application but was worried about the hours applied for and the noise; she hoped people could be encouraged to use the carpark; she was worried about deliveries taking place on King Street and she was concerned about the bass of any music played.

Mr Livesey responded to these concerns stating that his client had been advised to go for a wide licence but only really wanted to open at 11.30am. Also his last serving was at 1am in Preston with drinks not being served after 12.30am. He envisaged replicating this in this premises.

Mr Livesey then proposed that the Applicant would be prepared to alter the hours applied for so that the opening hours would be 11am to 1am Monday to Sunday and that the licensable activities would be 11am to 12.30am Monday to Sunday. He also stated that his client did not want to pursue the additional hours from the day British summer time starts which he had applied for, or those on the Thursday before Good Friday or the Sunday before bank holiday Mondays. Further, he only wished to have an additional hour on 24 & 26 December and New Year's Eve for both the opening hours and the licensable activities.

The Licensing Sub-Committee gave careful consideration to the representations made by all parties, both verbal and written. The Sub-Committee also considered the requirements of the Licensing Act 2003, the licensing objectives, the relevant regulations and the Council's licensing policy.

Having considered all of the above the Sub-Committee resolved to grant the application as applied for (including the conditions included in the schedule and Annex 3 and as agreed with the Environmental Health Department and set out as Appendix C to the Report) but incorporating the concessions offered by the Applicant at the hearing, so that the hours as set out in the premise licence will be as follows:
