I am writing to express my total objection to the proposal to widen the existing settlement boundaries at Highmoor Farm to allow for an additional 100 houses to be built.

Objection to new houses near Highmoor Farm

As you know, Clitheroe is undergoing major development at the moment especially in this area of town. The new housing development between the A59 and Pendle Road will extensively increase traffic in the area and subject the town's infrastructure to an enormous increase in population. I think the proposal will lead to even more issues garding the safety of the roads in this area, specifically the small roundabout at the junction to Highmore Park and Pendle Road. It is already a dangerous junction with traffic often very heavy and often too fast. The new roundabout on the A59 will greatly increase traffic on Pendle Road because in the past there was no right turn if travelling west, and in addition to this there will be the many cars from the hundreds of new houses that are being built. To increase the traffic further due to this proposed development would be dangerous and unacceptable.

Also to be taken into account is the destruction of habitat the development would cause. I regularly cycle in this area and have seen brown hares in the fields, there is not enough brown hare habiat in the UK and it's further destruction in this area would be detrimental to the bio-diversity in the area. Also of note are the ancient hedgerows which are another invaluable wildlife resource which can never be replaced. The greenbelt around Clitheroe is rich and diverse and to destroy the wonderful corridor of wildlife in this area of Highmoor Farm would be a tragedy. Too much disruption has already occurred in the development over the road and to accept the same destruction so close by would be totally unacceptable. I think it is extremely important to protect and conserve the network of mature hedgerows and trees that contribute to the distinctive landscape and sensitive ecology in this area.

In conclusion I strongly oppose the proposal to widen the existing settlement boundaries at Highmoor Farm to allow r an additional 100 houses to be built due to the added pressures on the already unsafe roads and due to the loss of ecological, historic character of the greenbelt area of Highmoor Farm.
