# SECTION 21 OF THE TOWN POLICE CLAUSES ACT 1847 (TCPA 1847) TEMPORARY TRAFFIC REGULATION ORDER (2025-1)

- 1.Ribble Valley Borough Council makes this Order in exercise of its powers under section 21 of the Town Police Clauses Act 1847 and any other enabling powers over an area of the highways being –
  - The length of Church Street/ Church Brow in the Town Centre of Clitheroe extending from the Town Hall to its junction with Market Place/ Wellgate\_\_\_\_
  - •The length of Market Place from its junction with Church Street / Wellgate to its junction with King Lane / King Street\_\_\_\_\_
  - •The length of Wellgate from its junction with Lowergate to its junction with Market Place/ York Street\_\_\_\_\_
  - •The length of Lowergate from its junction with King Lane to its junction with Wellgate\_\_\_\_\_
  - •The length of King Lane from its junction with Lowergate to its junction with Market Place\_\_\_\_\_

And shown coloured red on the plan attached to this Order.

- 2. The Order is made to avoid obstruction of the highways specified in paragraph 1 during the following event, Clitheroe Town Council Mayor Making 2025
- 3. The Order shall come into operation at 10.45am on Tuesday, 6 May 2025 and will remain in force until 01.15pm on Tuesday, 6 May 2025.

- 4.While the Order is in operation all traffic including bicycles and pedestrian movement along the road will be temporarily restricted (except for emergency access) between 10.45am and 01.15pm
- 5. There will be no alternative route available for the duration of the Order.
- 6.All restrictions will be signed (and staffed) and will remain in force only for as long as is necessary.
- 7.Nothing in the Order will apply to:
  - •Anything done with the permission of or at the direction of a Police Officer.
  - •Any vehicle being used for police, fire brigade or ambulance purposes or for the purposes of a statutory undertaker in an emergency, such as the loss of supplies of gas, electricity or water to premises in the area, which the Order applies.
- 8.Access to properties adjoining the highway specified in paragraph 1 will not be affected by the Order.
